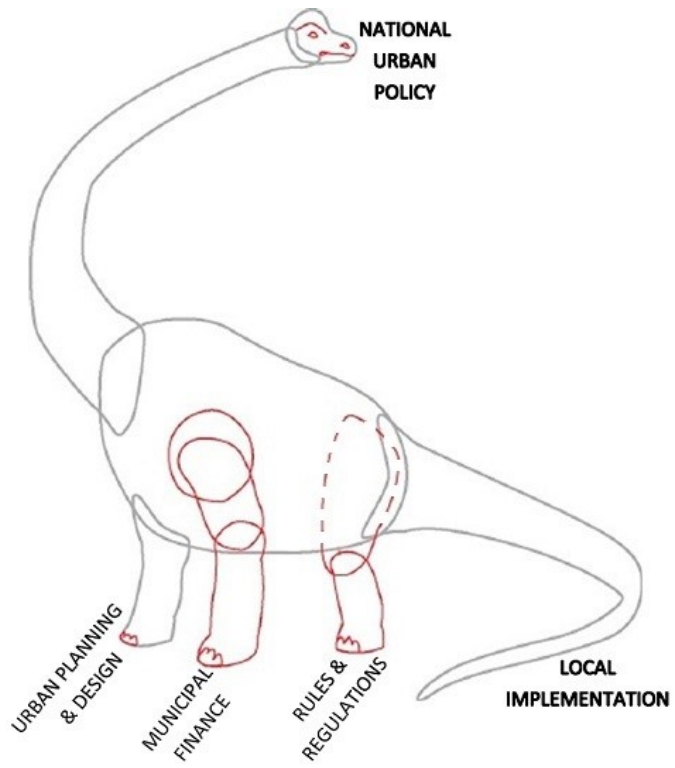

New resolution, 72 GA

OP5 “Invites UN-Habitat [...] [to] continue generating evidence-based and practical guidance for the implementation of the New Urban Agenda and the related dimensions of the 2030 Agenda, as well as to further develop the **action framework for the implementation of the New Urban Agenda**, in close consultation with Member States, local authorities and stakeholders;”

OP8 “Decides to continue to promote the normative work of UN-Habitat [...] in line with the principles and commitments of the New Urban Agenda and in support of the implementation of the **urban dimensions of the Sustainable Development Goals**;”



The good, the bad, and the ugly:



Transforming our world: the 2030 Agenda for Sustainable Development and thus the Sustainable Development Goals (SDGs) are “universal goals and targets which involve the entire world, developed and developing countries alike.”

The New Urban Agenda serves as one of the mechanisms to attain the SDGs:

- Not an isolated framework;
- Not a new layer of bureaucracy.

Role of local governments in implementing the 2030 Agenda and attaining the SDGs:

- Up to 70% of action implementing 2030 Agenda will be taken by sub-national authorities;
- Coordinated multi-level governance a key to success.

Financing the implementation of the Agenda 2030 and the New Urban Agenda:

- Alignment of existing streams of public and private investment;
- Breakthrough and innovation in blended frameworks of financing.
